Section (III) General Procedures

- 6. Each individual (whether alone or jointly with others) shall only be registered under **one** valid Registration of Intent (Form BH). Duplicated registration will not be accepted. The Registration of Intent (Form BH) is personal to the Registrant and shall not be transferable. The order of submission of the Registration of Intent (Form BH) will not have any impact on the order of priority for selecting the specified residential property(ies). In case of dispute, the Vendor reserves its right to determine whether a Registration of Intent (Form BH) is valid and should be included in balloting.
- 7. If a Registrant purchases any specified residential property(ies), the cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
